## ADDITION TO THE PERMANENT REGISTER OF ELECTORS FOR ONTARIO

To apply for personal addition to the Permanent Register of Electors for Ontario, please complete the attached '*Application for Addition to the Permanent Register of Electors for Ontario*' form and submit it with photocopies of proof of identity and proof of residence. Please see below for the list of documents that are considered acceptable as proof of identity and proof of residence.

Please return the completed '*Addition*' package, including the '*Application for Addition to the Permanent Register of Electors for Ontario*' form and photocopies of the required proof of identity and proof of residence documentation. Applications can be returned to Elections Ontario by mail to:

In order to ensure that all applications for personal addition to the permanent register of electors are included in the List of Electors for the October 10, 2007 provincial election, all '*Addition*' packages must be received at Elections Ontario by September 9<sup>th</sup>, 2007.

## Identification requirements for Addition to the Permanent Register of Electors for Ontario

To apply to be added to the permanent register of electors, you must show proof of identity and proof of residence.

- Option 1: You may use one of the documents from **List A** to meet this requirement; or,
- Option 2: You **must** use one document from **List B AND** one document from **List C**.

When applying for addition in person, only originals (or certified or notarized copies) will be accepted. Where the application does not need to be made in person, photocopies of identification will be accepted.

### List A: Identification shows Name, Address, and Signature

- An Ontario Driver's Licence with your residential or 911 address
- A new Ontario Health Card (it is your choice whether or not you want to show this card)
- An Ontario Motor Vehicle Permit (the plate portion) with your residential address
- A cancelled personalised cheque with your residential address
- A signed mortgage, lease, rental agreement for your residential address
- A signed insurance policy that lists your residential address
- A signed loan or financial agreement with a financial institution that lists your residential address
- A document issued or certified by a court in Ontario that shows your name, residential address, and signature
- Other documents:
  - Any document from the governments of Canada, Ontario, or a municipality in Ontario (or from one of their agencies) which has three elements: your name; your residential address; and, your signature. A Canadian passport does not qualify because the address is not printed on the passport by the government.
  - Any document from a Band Council in Ontario (established under the Indian Act) which has three elements: your name; your residential address; and, your signature.
  - A signed certification in the form provided by the Chief Electoral Officer.

### List B: Identification shows Name and Signature

- An Ontario Driver's Licence without your residential address or a 911 address
- An old or new Ontario Health Card (it is your choice whether or not you want to show this card)
- An Ontario Motor Vehicle Permit (the plate portion) without your residential address
- A Canadian Passport (one that is current or that has expired within the last 5 years)
- A Certificate of Canadian Citizenship
- A Federal Certificate of Indian Status
- A Veterans Affairs Canada Health Card
- A Social Insurance Number Card
- An Old Age Security Card
- A credit card that shows your name and signature
- A debit card that shows your name and signature

- A card, issued by the administration of a post-secondary institution, which shows your name and signature
- An ID card, issued by your employer, which shows your name and signature
- An ID card, issued by a trade union or professional association/licensing body, which shows your name and signature
- A signed mortgage, lease, rental agreement for a property in Ontario
- A cancelled personalized cheque
- A signed insurance policy that has your name and signature
- A signed loan or financial agreement with a financial institution that has your name and signature
- A document issued or certified by a court in Ontario that shows your name and signature
- Other documents:
  - Any other document issued by the governments of Canada, Ontario, or a municipality in Ontario (or one of their agencies) which shows your name and signature
  - Any document issued by a Band Council in Ontario (established under the Indian Act) which shows your name and signature.

### **List C: Identification shows Name and Address**

- An Ontario Motor Vehicle Permit (the vehicle portion) with your residential address
- An Income Tax Assessment Notice
- A Child Tax Benefit Statement
- A Statement of Employment Insurance Benefits Paid T4E
- A Statement of Old Age Security T4A (OAS)
- A Statement of Canada Pension Plan Benefits T4A (P)
- A Canada Pension Plan Statement of Contributions
- A Statement of Direct Deposit for Ontario Works
- A Statement of Direct Deposit for Ontario Disability Support Program
- A Workplace Safety and Insurance Board Statement of Benefits T5007
- A Property Tax Assessment for your residential address
- An insurance statement which shows your name and residential address
- A mortgage, lease, or rental statement which shows your name and residential address
- A credit card, bank account, RRSP, RRIF, RHOSP, or T5 statement which shows your name and residential address
- A CNIB Card (or card from another registered charitable organization which provides services to persons with disabilities) which shows your name and residential address
- A hospital card or record which shows your name and residential address
- A card or document, issued by the administration of a post-secondary institution, which shows your name and university residence (if claimed as your permanent residence)
- A utility bill (hydro, water, gas, telephone, cable TV, public utilities commission) which shows your name and residential address
- A cheque stub, pay receipt, or T4 issued by your employer
- A post-secondary school transcript or report card which shows your name and residential address
- Other documents:
  - Any document issued by the governments of Canada, Ontario, or a municipality in Ontario (or one of their agencies) which shows your name and residential address
  - Any document issued by a Band Council in Ontario (established under the Indian Act) which shows your name and residential address.
