NOTE: Every person who makes improper use of the Proxy Provisions of the Election Act is liable to a fine of up to \$5,000 or a term of up to 6 months imprisonment or both.

- resided in Ontario for at least 12 consecutive months before departure, and
- whose last Ontario residence was in this electoral district, and
- who intends to reside in Ontario again

Section 2: Statement By Person Appointing The Proxy

I the undersigned, named above as the person appointing the proxy, hereby state that I am a qualified elector and entitled to vote at the election now pending in Ontario but that I expect to be unable to cast my own ballot.

The elector named below and appointed by me as my voting proxy is someone I know and who was chosen by me of my own free will to present this application on my behalf and to cast my ballots according to my wishes and direction.

I further state that I have not already voted at this election and that I have not made any other application to vote by proxy nor any other appointment of a proxy voter.
