AUDITORS' REPORT

To Frances Richardson, Chief Financial Officer for College of Dental Hygienists of Ontario

We have audited the Statement of Election Advertising Income and Expenses of College of Dental Hygienists of Ontario, under the requirements of subsection 37.12 of the Election Finances Act for the election held on October 10, 2007. This financial information is the responsibility of the Chief Financial Officer of College of Dental Hygienists of Ontario. Our responsibility is to express an opinion on this financial information based on our audit.

Except as explained in the following paragraph, we conducted our audit in accordance with Canadian generally accepted auditing standards. Canadian generally accepted auditing standards require that we plan and perform an audit to obtain reasonable assurance whether the financial information is free of material misstatement. An audit includes examining on a test basis, evidence supporting the amounts and disclosures in the financial information. An audit also includes assessing the accounting principles used and significant estimates made by the CFO, as well as evaluating the overall financial information presentation. The Act, however, does not require us to report, nor was it practicable for us to determine, that contributions reported included only those which may be properly retained in accordance with the provisions of the Act.

Due to the nature of the types of transactions inherent in any election campaign, the completeness of the various categories of income and expenses is not susceptible of satisfactory audit verification. Accordingly, our verification of income and expenses was limited to the amounts recorded in the third party election advertising records and we were not able to determine whether any adjustments might be necessary to advertising income and expenses.

In our opinion, except for the effect of the adjustments, if any, which we might have determined to be necessary, had we been able to satisfy ourselves concerning the completeness of advertising income and expenses referred to in the preceding paragraph, this Statement presents fairly, in all material respects, the Advertising Income and Expenses of the College of Dental Hygienists of Ontario for the election held on October 10, 2007 in accordance with the accounting requirements of Election Finances Act and the guidelines issued by the Chief Electoral Officer.

This financial information is solely for the information and use of the Chief Electoral Officer to comply with subsection 37.12 EFA. This financial information is not intended to be and should not be used by anyone other than the specified users or for any other purpose.
