Documentation for removing a deceased person from the register(s)

To remove a deceased person from the register(s) maintained by Elections Ontario, you must provide proof of death documentation.

#### **Examples of accepted documents showing proof of death**

- Burial or death certificate
- Document/receipt issued by a cemetery/crematorium in Ontario that proves burial or cremation
- · Life or Group Insurance claim along with a statement signed by a medical doctor
- Medical Certification of Death
- · Memorandum of notification of death issued by the Chief of the National Defence Staff
- Notarial copy of Letters of Probate
- Statement of Verification of Death from the Department of Veterans Affairs
- Obituary from a newspaper
- Official notification from the Public Trustee
- Program or notice from a funeral ceremony
- · Registration of Death
- Statement from a medical doctor, a coroner or a funeral director
- Any other applicable document from the Government of Canada, a Canadian province or territory, a municipality in Canada, or from its agency proving a person's death
