

Eligibility & Requirements

This application can be submitted by mail or email to add, update or remove your information from the voters list and registers maintained by Elections Ontario. You can also register online at eregistration.elections.on.ca.

This application can be used to request that your information be:

- added to the voters list;
- updated on the voters list (if your information has changed, or if you've resumed residency in Ontario); or
- removed from the voters list or Register of Absentee Electors.

To be eligible, you must be:

- 18 years of age or older;
- a Canadian citizen; and
- · a resident of Ontario.

You will need to submit one piece of ID with your name and current residential address. Find examples of ID on the provided List of Acceptable ID included in this package.

The completed application and a copy of an acceptable ID can be submitted in one of two ways:

Important Information

Eligible electors who have requested to remove their information are still eligible to vote; however, you will not receive a voter information card if an election is called in your electoral district.

ID requirements for adding, updating or removing your information on the voters list and registers

To add, update or remove your information on the voters list and registers, you must include one piece of ID showing both your name and current residential address.

Examples of government-issued ID

- Any document showing both your name and address issued by:
 - the Government of Canada Government statement
 - the Government of Ontario
 - a municipality
 - a government agency
- Band council documentation
- Government cheque stub
- Government statement of benefits or El
- Income tax assessment
- Ontario driver's licence
- Ontario motor vehicle permit
- Ontario photo card
- Property tax assessment
- T4 tax slip

Examples of other acceptable documents, providing they show both name and address

- Bank statement
- CNIB ID card
- Credit card statement
- Credit union statement
- Hospital documentation
- Hospital record
- ID issued by Inuit authority
- Insurance certificate, policy or statement
- Letter from an academic institution

- Letter from a public curator, public guardian or public trustee
- Letter of confirmation of residence from a First Nations band or reserve or an Inuit local authority
- Medical clinic card
- Mortgage contract or statement
- Pay stub

- Pension plan statement
- Personal cheque
- Public transportation card
- Residential lease or sub-lease
- School transcript or report card
