

## Eligibility & Requirements

This application can be submitted by email or mail to update, add or remove your information from the Ontario Register of Future Voters. You can also register online at <u>eregistration.elections.on.ca</u>.

This application can be used to request that your information be:

- added or removed: or
- updated (if your information has changed).

To be eligible, you must be:

- 16 or 17 years of age;
- a Canadian citizen; and
- a resident of Ontario.

You will need to submit one piece of ID with your name and home address. The information on your ID must match the information you are submitting.

#### Important Information

If you are on the Ontario Register of Future Voters, you will be automatically added to the Register once you turn 18.

Only the applicant can update, add or remove their information from the Ontario Register of Future Voters. We will not accept forms submitted on behalf of another person.

The personal information of future voters is used by Elections Ontario to update the Register. It is not shared with other political entities or other electoral management bodies (e.g. Elections Canada). Once you turn 18, your information will be automatically added to the Register and Elections Ontario may share voter information with Elections Canada, the Municipal Property Assessment Corporation (MPAC) and some municipalities, as requested, for election purposes only.

Elections Ontario is committed to protecting the privacy and security of personal information. Information collected and maintained by Elections Ontario is only used for electoral purposes under the provisions of the *Election Act*.

ID requirements for updating, adding or removing your information from the Ontario Register of Future Voters

To update, add or remove your information from the Ontario Register of Future Voters, you must include one piece of ID showing both your name **and** home address. Ontario health cards, citizenship cards or passports do not include your address and are not valid ID for registration purposes.

#### **Examples of government-issued ID**

- Any document showing both your name and home address issued by the Government of Canada/Ontario
- Ontario driver's licence
- Ontario motor vehicle permit (plate or vehicle portion)
- Ontario photo card

- Property assessment notice from Municipal Property Assessment Corporation (MPAC)
- Child tax benefit statement
- Income tax assessment notice
- Social Insurance Number confirmation letter
- Statement of Employment Insurance Benefits Paid T4E
- Statement of Old Age Security T4A (OAS)

## Examples of other accepted documents showing both name and home address

- Any document showing both your name and home address issued by:
  - a municipality
  - a government agency
  - or certified by a court in Ontario
  - a Band Council in Ontario established under the Indian Act (Canada)
- Document showing campus residence issued by the office or officials responsible for student residence at a postsecondary institution
- School admission letter

- School transcript or report card
- Tuition/fees statement
- Bank account or credit card statement
- Cancelled personalized cheque
- Cheque stub, pay receipt or T4 issued by a person's employer
- Insurance statement
- Residential mortgage, lease, or rental statement
- Signed loan or financial agreement with a financial institution

- CNIB card or a card from another registered charitable organization that provides services to persons with disabilities
- Hospital records containing a person's name and home address
- Letter of Confirmation of Residence
- Utility bill (hydro, water, gas, telephone, cable TV, public utilities commission)
- Property tax assessment or bill from a municipality in Ontario


