

Eligibility & Requirements

This application can be submitted by email or mail to update, add or remove your information from the registers maintained by Elections Ontario. You can also register online at eregistration.elections.on.ca.

This application can be used to request that your information be:

- added to the Register;
- updated on the Register (if your name and/or your home address has changed); or
- removed from the Register or Register of Absentee Electors.

To be eligible, you must be:

- 18 years of age or older;
- a Canadian citizen; and
- a resident of Ontario.

You will need to submit one piece of ID with your name and home address. The information on your ID must match the information you are submitting.

Legal Name Change Requirements

An elector listed on any of the registers maintained by Elections Ontario who has changed their legal name or assumed or unassumed the use of a spouse or partner's name must submit **two pieces of ID** with their completed application.

1. One ID showing their previous name and home address **AND** one ID showing their current name and home address;

OR

2. Change of name certificate issued by a provincial/territorial registrar or a marriage certificate **AND** one ID showing their current name and home address.

Important Information

Eligible electors who have requested to remove their information are still eligible to vote; however, they will not receive a voter information card if an election is called in their electoral district.

Elections Ontario is committed to protecting the privacy and security of personal information. Information collected and maintained by Elections Ontario is only used for electoral purposes under the provisions of the *Election Act*.

ID requirements for updating, adding or removing your information from the registers

To update, add or remove your information from the registers, you must include one piece of ID showing both your name **and** home address. Ontario health cards, citizenship cards or passports do not include your address and are not valid ID for registration purposes.

Examples of government-issued ID

- Any document showing both your name and home address issued by the Government of Canada/Ontario
- Ontario driver's licence
- Ontario motor vehicle permit (plate or vehicle portion)
- Ontario photo card
- Property assessment notice from Municipal Property Assessment Corporation (MPAC)
- Child tax benefit statement
- Income tax assessment notice
- Social Insurance Number confirmation letter
- Statement of Employment Insurance Benefits Paid T4E
- Statement of Old Age Security T4A (OAS)

Examples of other accepted documents showing both name and home address

- Any document showing both your name and home address issued by:
 - a municipality
 - a government agency
 - or certified by a court in Ontario
 - a Band Council in Ontario established under the *Indian Act* (Canada)
- Document showing campus residence issued by the office or officials responsible for student residence at a post-secondary institution
- School admission letter
- School transcript or report card
- Tuition/fees statement
- Bank account or credit card statement
- Cancelled personalized cheque
- Cheque stub, pay receipt or T4 issued by a person's employer
- Insurance statement
- Residential mortgage, lease, or rental statement
- Signed loan or financial agreement with a financial institution
- CNIB card or a card from another registered charitable organization that provides services to persons with disabilities
- Hospital records showing a person's name and home address
- Letter of Confirmation of Residence
- Utility bill (hydro, water, gas, telephone, cable TV, public utilities commission)
- Property tax assessment or bill from a municipality in Ontario
