This form is available in hard copy or soft copy on the Elections Ontario website. Please print clearly or type. This form must be completed and filed with the Chief Electoral Officer before any financial activity occurs. There is no fee to register as a leadership contestant with the Chief Electoral Officer of Ontario.

Forms may be submitted by any conventional delivery method, including mail, fax, email or hand delivery.

## A. LEADERSHIP CONTESTANT INFORMATION

Provide the name of the political party holding the leadership contest, as well as the name, address and contact information of the leadership contestant.

## Type of Registration

A new registration is the initial registration of a leadership contestant with the Chief Electoral Officer. For a new registration, complete Sections A through I.

A change notice is for informing the Chief Electoral Officer of any changes to the initial registration. For any changes, a revised LC-1 must be submitted immediately. For a change notice, complete Sections A through H.

## B. CAMPAIGN OFFICE AND MANAGER

Appointing a campaign manager is optional. This section may be left blank. However, the information is useful if the Chief Electoral Officer needs to contact the campaign office.

## C. CHIEF FINANCIAL OFFICER (CFO)

Every leadership contestant must appoint a CFO. The leadership contestant cannot be the CFO. Provide the name, address and contact information of the CFO.

## D. AUDITOR

Every leadership contestant is required to appoint an auditor within 30 days of receiving contributions of at least \$10,000 or incurring expenses of at least \$10,000, with respect to a leadership contest. The auditor or firm whose partners resident in Ontario must be licensed under the Public Accounting Act, 2004. The CFO cannot be the auditor.

## E. PERSON(S) AUTHORIZED TO ACCEPT CONTRIBUTIONS

Provide the name(s), address(es) and contact information of any the person(s) who are authorized to accept contributions and make deposits. The leadership contestant is not allowed to accept contributions.

#### F. PLACE WHERE RECORDS ARE KEPT

Provide the name of the record keeper and address of the place in Ontario where the financial records are kept.

## G. FINANCIAL INSTITUTION(S) AND SIGNING OFFICER(S)

Provide the name and address of each financial institution in which a campaign account has been opened. If there is more than one financial institution, attach a separate sheet. Provide the name(s), address(es) and contact information of the signing officer(s) for each financial institution account.

### H. CERTIFICATION OF LEADERSHIP CONTESTANT AND CFO

The leadership contestant and CFO must complete and sign this section.

## I. CERTIFICATION OF POLITICAL PARTY'S CFO

The CFO of the registered political party holding the leadership contest must complete this section. The political party's CFO signing the form must be currently on file with the Chief Electoral Officer as per the filed Political Party Registration and Change Notice Form (P-1).

It is the leadership contestant's responsibility to file a complete and accurate registration form with the Chief Electoral Officer. Failure to provide the information required will delay the registration until all the required information is provided.

The leadership contestant is considered to be registered on the day the form is received by the Chief Electoral Officer providing the form is properly completed and has the required signatures.

This form may be inspected during office hours of Elections Ontario. Any person may make extracts from the documents and is entitled to copies of the documents upon payment for their preparation at such rate as the Chief Electoral Officer may determine. Certain data will also be extracted from the information filed and displayed on the Elections Ontario website.
